2. Review Quotes for Sidewalk to Gazebo

Supervisor DePasquale reported the following three quotes for the sidewalk to the Town Gazebo:

Southtowns Design

4"thick, wire mesh in all, joints cut, seal, acrylic seal applied

Stamped \$6,720 Color \$4,780. Stained \$3,740.

Concrete Cowboy

5' by 96' and 5' by 33' of sidewalk at the Town Hall will be 400psi concrete at 4" thick to be stamped and saw cut and cleaned and sealed. Color and stamp to be decided later

Stamped \$3,800. Plain Concrete \$3,200.

Bernie Horschel

Concrete walk (sunset rose) \$5,100. Concrete walk (tile red) \$5,525.

Add for slate stamp \$275.

There are funds left over from Martha Kalinowski's donation that should help cover the cost of the sidewalk. The Town Board discussed the three quotes and will approve at tonight's Regular meeting.

3. Update on Gazebo Concert Series

Supervisor DePasquale stated that a postcard with the schedule of the bands to play at the gazebo hasbeen mailed out and posters and banners have also been printed with the sponsor names.

The first concert was cancelled due to the weather conditions and will try to reschedule that band for another date; the next concert will be June 27th. At the August 8th concert a local car club "Colden Cruise Club" would like to participate in the event.

An action plan has been updated along with the insurance coverage and concert package added to the plan.

4. Update on Purchase of Land for Park

Supervisor DePasquale stated that a survey will be completed before the closing of the property.

Councilwoman Zurbrick asked for a dog station in front of the Senior Center there are residents that just do not clean up after their dogs in that area and are parks employee is left to clean up after the dogs.
