-Main Goals of Tonight's Planning Board Meeting: Due to the nature of the in-person and virtual meeting efficiency we will limit our actions for this meeting to:

## (1) <u>Colden's Southern Tier Trail (STT) Update from GoBike's Ashley Smith and STT</u> Coordination Meeting with the Colden Planning Board's Staff:

As an alternative when the AFPP schedule changed, we have made arrangements to have Ashley Smith of GoBike and the pending Southern Tier Trail (related to Colden's Rail to Trail multiuse

conversion of the old rail bed) activity SPECIFICALLY ASTO HOW IT RELATES TO COLDEN AND THE SEGMENT THROUGH THE TOWN.

Ashley will make a formal presentation on the STT, and she has prepared a "Colden specific" booklet for discussion, and subsequently will have a dialog with the Colden Planning Board with respect to this whole topic and GoBike's STT engineering design status. There was some confusion in the material discussed during the Planning Board's 21Sep21 Erie-Cattaraugus-Rail-Trail meeting (which ended up not having formal presentation materials and handouts as previously expected).

The Colden Planning Board wants to afford GoBike/STT the same unfettered opportunity (as the ECRT representatives had) to have a dedicated session with our Planning Board, without diversion from potentially differing materials or ideas. Thus, the Planning Board will get exposed to the GoBike/STT, engineering design status and progress, and of course GoBike's funding allocation concepts as related to the Ralph Wilson Foundation's support for the STT. All of this will be from a viewpoint as applicable to Colden's STT segment. Ashley will also update us on the Alta Engineering Report (GoBike's engineering consultants) and some details as to how it defines the trail segment in Colden as envisioned by the Wilson Foundation and GoBike.
